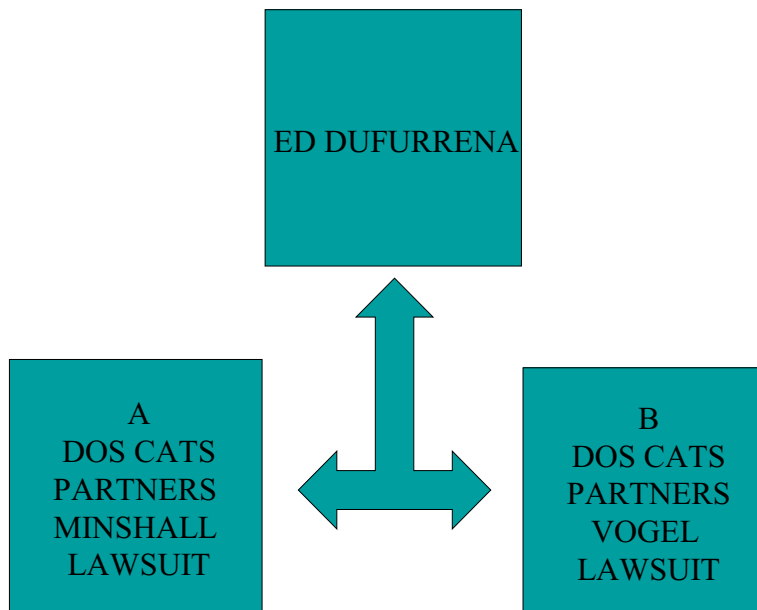


**DUFURRENA "DOS CATS PARTNERS" CHART'S & "RISK ANALYSIS" -
Richard E. "Rick" Dennis, WIND RIVER COMPANY L.L.C. - Analyst**

A: Established 2006 - AQHA Records. "Auspicious Cat" included therein. The lawsuit is entitled: "Shawn, Lisa Victoria & Lauren Minshall vs. Ed Dufurrena, Ed Dufurrena CH, Anthony and Dufurrena, Hartman Equine, Reproduction Center (HERC) and "DOS CATS PARTNERS - "DEFENDANTS."" This Lawsuit was filed on October 30, 2015. Court records indicate an "out-of-court" settlement was reached on April 26, 2016 with Edward L. Dufurrena, Edward Dufurrena Cutting Horses LLC, Anthony and Dufurrena, Inc., Dos Cats Partners, Karen Claycomb, Tom Donahue, Gary Craighead, Barbara Hanselman, Michael Nolan, Tracy A Agrall, Butch Reddish and Blair Vissar.

B: This federal lawsuit specifically states: "Current and former members of "Dos Cats Partners" - (A), which were sued and subsequently reached an "OUT-OF-COURT" settlement with the Plaintiffs; Minshall's, in this case. However, the "VOGEL'S" are absent, in the court filings and/or pleadings even though, "Dos Cats Partners" - (B); including the Vogel's, was established on March 25, 2011 - and/or four (4) years earlier, on a handwritten piece of paper and signed by all parties - Vogel

and Dufurrena.

- C. AQHA records indicate "Auspicious Cat" was transferred into the "Dos Cat Partners AQHA Registry"; date of sale 12/30/06, date of AQHA registry transfer being finalized on January 16, 2008. Click for "Auspicious Cat" AQHA registry."
 - D. Defendants are sued for "FRAUD."
2. "DOS CATS PARTNERS " - Hand Written Partnership (Vogel's), March 25, 2011, Exhibit "B":
- A: Established on March 25, 2011 by and between Ed Dufurrena, Eugene, and Janie Vogel. The Vogel's invest \$105,000.00 and acquire 49% of the "Dos Cats Partners," which includes a hand written contract as well as specifying an invested share percentage of specific and included horses an embryo's, named therein. Dufurrena retains a 51% share of the partnership.

 - B: A Lawsuit entitled: Donald Eugene Vogel and Janie S. Vogel (Plaintiffs) versus Edward L. Dufurrena (Defendant) is filed in the State of Texas, County of Cooke 235th District Court, on October 2, 2017.
 - C: "Allegations of "FRAUD" resurface in filed court documents by Eugene and Janie Vogel." Allaboutcutting.net article.
 - D: This court case also results in an "OUT-OF-COURT", Settlement.
3. The "prima facie" evidence concludes the existence of two (2) separate "Dos Cats Partners": involving separate named individuals occurring between 2006 and 2017; (A) and (B) in the foregoing, and evidenced by remittance of AQHA records and filed court documents. Also, the "prima facie" evidence concludes the exact identities of (2) reoccurring entities in the separate filed lawsuits, i.e., Edward L. Dufurrena and "Auspicious Cat."
- This "prima facie evidence " ; i.e., the confirmed existence of "Dos Cats Partners" - Exhibit's - (A) and (B), in the foregoing is evidenced and corroborated by Edward L. Dufurrena in his letter to the NCHA Officers and Directors, attached hereto. However, the missing piece of the puzzle is the end date of "Dos Cats Partners" - Exhibit (A), in the foregoing.
4. The "How and Why", the "Vogel's" were excluded from lawsuit

Exhibit (A); in the foregoing, is up to the attorneys to determine, especially in lieu of the phrase "current and former" members of the "Dos Cats Partners" included in the Minshall lawsuit which ultimately ended in an "OUT-OF-COURT" settlement with Dufurrena and "Dos Cats Partners"; excluding the "Vogel's". However, the "OUT-OF-COURT" settlement details of Exhibit (A) in the foregoing aren't known. However, the details of the "OUT-OF-COURT" settlement in Exhibit (B) settlement are known.
